Dear Motor/Powersport Vehicle Franchisee or Franchisor:

The Utah Legislature enacted the New Automobile Franchise Act in 1996 to protect the public interest by helping to ensure fair business practices between motor vehicle franchisors and franchisees. Utah Code Annotated §13-14-105(1) requires that a franchisee or franchisor doing business in this State shall annually register or renew its registration with the Department and pay an annual registration fee.

Whether you are registering for the first time or you have previously registered as a franchisee/franchisor, please return the following information along with your annual registration fee of **\$83.00**. Please reference the enclosed form. The New Automobile Franchise Act covers sales of NEW:

Self-propelled vehicles, trailers, travel trailers, semitrailers,  
etc. Utah Code Ann. §13-14-102(16) - (17).

The Utah Legislature similarly enacted the Powersport Vehicle Franchise Act in 2002 to ensure fair business practices between powersport franchisors and franchisees. That Act covers sales of NEW powersport vehicles, including:

All-terrain type I, type II and type III "ATV"  
vehicles, snowmobiles, motorcycles, mopeds,  
motor-driven cycles, and personal watercraft. Utah  
Code Ann. §13-35-102(12).

The Act requires that powersport vehicle franchisees and franchisors doing business in Utah register with the Department of Commerce and pay an annual registration fee. Whether you are registering for the first time or have previously registered as a powersport franchisee or franchisor, please return the following information along with your annual registration fee of **\$83.00**. See enclosed form.

**PLEASE NOTE:** The registration fee for a franchisee/franchisor who deals in both new motor vehicles and new powersport vehicles is **\$110.00**. See enclosed form.
